**2017 RESOLUTION CHANGE ORDERS**

**AUTHORIZING A SECOND AMENDMENT TO A PROFESSIONAL SERVICE CONTRACT FOR ARCHITECTURAL DESIGN SERVICES FOR THE RENOVATIONS OF THE BLOOMFIELD MUNICIPAL COURT AND VIOLATIONS BUREAU**

WHEREAS, the Township of Bloomfield had a need to acquire professional services of a Licensed Architect to prepare a design, bid documents and construction administration services for the renovations to the Bloomfield Municipal Court and Violations Bureau and

WHEREAS, the Mayor and Council approved a fair and open contract with the Goldstein Partnership, 515 Valley Street, Suite 110, Maplewood, New Jersey 07040 (hereinafter "Professional") in an amount not to exceed \$39,500.00 and a subsequent amendment of \$30,250.00 for an amended contract price of \$69,750.00; and

WHEREAS, during the course of the design phase, and various meetings with municipal and court officials, the original scope of the work required further expansion to include the following improvements:

- Additional mechanical work and design to accommodate an elevator to provide fully compliant ADA accessibility to the renovated violations bureau.
- Design and coordination of a new security access system to properly coordinate access to secured and unsecured areas of the Police Department as well as the Violations/Court area. The current facility-wide security access system will require upgrade and replacement.
- Expansion of the building phasing plan to include relocation of the municipal court to the municipal council chambers; and

WHEREAS, the professional provided a proposal to increase the scope of work in an additional amount of \$30,250.00, thereby increasing the total professional service contract price to a cost not to exceed \$100,000.00; and

WHEREAS, the construction of this project was awarded to AB Designs Construction

**WHEREAS**, the amended professional service contract for design, construction administration and inspection of the project represents 14.8 percent of the construction costs, which is below the common, accepted, estimated cost range of 15 to 20 percent of the construction costs for such services; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of these services within Capital Account # C-04-55-713-947; and

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield hereby approve an amendment to the professional service contract for architectural services in an additional amount not to exceed \$30,250.00.

**BE IT FURTHER RESOLVED**, that no minimum payment is implied or guaranteed; and

**BE IT FURTHER RESOLVED**, that the Business Entity Disclosure Certification, the Township Engineer's Determination of Value, the proposal of the Professional and the contract itself be placed on file with this resolution; and

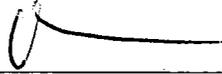
**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed on a pro-rated amount if the contract calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.

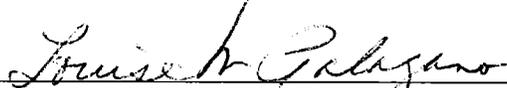
