**2017 RESOLUTION APPOINTMENT**

**AUTHORIZATION**

**WHEREAS**, the Township of Bloomfield needs the services of a Utility Audit Service;  
and

**WHEREAS**, the Mayor and Council of the Township of Bloomfield hereby appoint George A. Koteen Associates, Inc., 290 Queen Anne Road, Teaneck, NJ to perform the Utility Audit Service to the Township of Bloomfield; and

**WHEREAS**, George A. Koteen Associates, Inc. will conduct audits, correct and submit recommendations for all possible savings, refunds, credits or adjustments due, based on charges on the Township's electric, gas, water, sewer and telecommunications bills; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in account #7-01-32-827-27R, There is no Not to Exceed amount on this agreement; and

**WHEREAS**, the Township of Bloomfield and George A. Koteen Associates, Inc. have both agreed that the Township shall not be required to pay any retainer or advance fees of any kind. The Vendor (George A. Koteen Associates, Inc.) shall be paid 50% of all savings secured through Vendor's efforts, in accordance with the agreement. Vendor shall also be paid 50% of each refund, credit, or adjustment secured through Vendor's negotiations and other efforts.






