**2017 RESOLUTION APPOINTMENT**

**PUBLIC SAFETY DIRECTOR**

**WHEREAS**, the Mayor and Council believe it is in the Township's best interest to delegate administrative Public Safety functions to a Public Safety Director; and

**WHEREAS**, the Public Safety Director will retain principal administrative authority for the operations of the Fire Department (BFD), Police Department (BPD), EMS and Office of Emergency Management (OEM) (collectively, the "Agencies"); and

**WHEREAS**, the Public Safety Director shall be responsible for the following:

- a. Providing planning and policy leadership for all Township wide public safety initiatives required by any department, office or agency of the Township, except as otherwise directed by the Mayor or the Township Administrator;
- b. Formulating policies, procedures, standards and oversight for all public safety projects undertaken by any municipal department;
- c. Establish performance criteria for BPD, BFD, EMS and OEM;
- d. Shall regularly report to the Mayor and Township Administrator with recommendations related to conditions of the Agencies and suggestions for their improvement and needs;
- e. The Public Safety Director shall be the Chief Executive Officer of the BPD, BFD, EMS and OEM;
- f. Make, administer and enforce rules and regulations for the control, disposition and discipline of the Agencies, and of its officers and employees;

- g. Establish procedures for the hearing and determination of charges of violation of the respective departmental rules and regulations of the Agencies by any member provided that a member may be fined, reprimanded removed, suspended or dismissed from the respective department only on written charges made or preferred against him or her, after such charges have been examined, heard and investigated, upon such reasonable notice to the member charged, and according to such practice, procedure and manner as may be prescribed by rules and regulations of the respective department;
- h. In his discretion, deduct and withhold salary from any member of the Agencies on account of absence for any cause without leave in accordance with Civil Service procedures or common law;
- i. The Fire Chief and OEM Coordinator shall retain full authority for the following respective operations: All fire operations and control shall remain with the Fire Chief; All OEM operations shall remain with the OEM Coordinator

**WHEREAS**, the Township Administrator recommends that Samuel De Maio be appointed to the position of Public Safety Director; and

**WHEREAS**, Samuel De Maio has indicated a desire to fill this position; and

**WHEREAS**, Mr. De Maio will continue serving as BPD Police Director; and

**WHEREAS**, Mr. De Maio will not receive additional compensation for this position other than the salary he receives as Township of Bloomfield Police Director.

**NOW, THEREFORE, BE IT ORDAINED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby appoint Samuel De Maio as the Public Safety Director for the Township of Bloomfield effective June 13, 2017.


