**2017 RESOLUTION CHAPTER 159**

**RESOLUTION REQUESTING APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION NJS 40A:4:87**

**BUDGET CHAPTER 159/5**

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of any items of appropriation for equal amount; and


**WHEREAS**, after the 2017 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$79,359.52 from State of NJ 2017 Clean Communities Grant - Account #7-01-40-305-000.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council authorizes the Township Administrator to execute any documents necessary to receive the \$79,359.52 2017 Clean Communities; and

**BE IT FURTHER RESOLVED**, that Township of Bloomfield hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the Budget of the year 2017 in the sum of \$79,359.52 as an anticipated revenue from the State of NJ 2017 Clean Communities Grant - Account # 7-01-40-305-000; and

**BE IT FURTHER RESOLVED**, that a like sum of \$79,359.52, be and the same is hereby appropriated under the Budget of the Township of Bloomfield State of NJ 2017 Clean Communities Grant - Account #7-01-40-305-029; and


