**2017 RESOLUTION APPROVAL**

**AWARD OF THREE YEAR CONTRACT TO DELTA DENTAL FOR TOWNSHIP'S DENTAL INSURANCE**

WHEREAS, RD Parisi Assoc., is currently the Township's Dental benefits broker; and

WHEREAS, RD Parisi Assoc. has received quotes to provide the Township Dental benefits from four providers; and

WHEREAS, the Director of Finance has review the proposal submitted and recommends that the Township enter into an agreement with Delta Dental for 3 years at the following rates;
