**2017 RESOLUTION APPOINTMENT**

**APPOINTMENTS TWO (2) DPW LABORERS**

**WHEREAS**, Anthony Piacenza and Gerard Pray were employed by the Bloomfield Parking Authority at the time of its dissolution; and

**WHEREAS**, the Director of the Department of Public Works and Parks (DPW) is recommending that Anthony Piacenza and Gerard Pray are hired as DPW Laborers; and

**WHEREAS**, the Director of Finance has indicated that funding is available for these positions.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorizes hiring the above referenced employees as full-time DPW Laborers effective September 19, 2017, starting at step 1, which is set forth in the Township salary ordinance for that position.

**BE IT FURTHER RESOLVED**, that this appointment is subject to the Bloomfield Township Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield, to maintain such residency, and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharge from employment.


