2017 RESOLUTION APPROVAL

RESOLUTION OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX DESIGNATING METRO REAL ESTATE DEVELOPMENT CORP. AS THE CONDITIONAL REDEVELOPER OF A PORTION OF THE BLOOMFIELD CENTER REDEVELOPMENT AREA


WHEREAS, by resolution duly adopted on December 18, 2000, the Township of Bloomfield (the "Township") designated a portion of the Township, consisting of the properties then identified as Block 220, Lot 40, Block 225, Lots 1 and 9, Block 227, Lots 1, 3, 5, 6, 8, 9, 10, 11, 12, 13, 15, 16, 17, 19, 20, 22, 24, 26, 30, 31, 32 and 35, Block 228, Lots 1, 4, 5, 7, 8, 10, 11, 13, 14, 15, 16, 17, 18, 19, 21, 24, 27, 28, 29, 30, 31, 33 and 35, and Block 243, Lots 1, 3, 4, 5, 6, 7, 8, 10, 11, 13, 15, 17, 18 and 20 on the Township's tax map (collectively, the "Redevelopment Area"), as an area in need of redevelopment pursuant to the New Jersey Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. (the "Redevelopment Law"); and

WHEREAS, by ordinance finally adopted on December 15, 2008, the Township approved and adopted a Redevelopment Plan for the redevelopment of the Redevelopment Area (the "Redevelopment Plan"); and

WHEREAS, Metro Real Estate ("METRO") proposes to redevelop the portion of the Redevelopment Area known as Block 227, Lot 26 on the Township's tax map (the "Project Area"); and

WHEREAS, the Township of Bloomfield Parking Authority owns the Project Area; and

WHEREAS, the Township now desires to designate METRO as the conditional redeveloper of the Project Area, in furtherance of entering into a formal redevelopment

agreement with METRO, with said preliminary negotiations to include the receipt and review of additional project specific information from METRO as may be requested.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Mayor and Council of Township of Bloomfield, in the County of Essex and the State of New Jersey, as follows:

Section 1. METRO is hereby conditionally designated as the redeveloper of the Project Area and has, at the sole and exclusive discretion of the Township, the option to enter into preliminary negotiations for a redevelopment agreement with the Township in connection with the Project Area.

Section 2. The within designation is hereby made for a limited period of one hundred eighty (180) days, and is further contingent upon METRO providing any additional project related information as may be requested by the Township.


Section 3. The within designation is further contingent upon METRO agreeing to reimburse the Township for any and all costs associated with the Township's review of said additional material and any efforts involved in designating METRO as the conditional redeveloper of the Project Area and negotiating a formal redevelopment agreement between the Township and METRO. Said costs shall include, but not be limited to, the cost of any and all professional consultants retained by the Township to review said materials and/or assist the Township in negotiations of a formal redevelopment agreement, including such costs incurred prior to the date of adoption of this resolution.

Section 4. The Mayor is hereby authorized to execute an Interim Costs Agreement by and between the Township and METRO, in substantially the same form as that on file with the Township Clerk, along with such additions, deletions or modifications as the Mayor may deem necessary, after consultation with counsel.

Section 5. This resolution shall take effect immediately
