2019 RESOLUTION APPROVAL

RESOLUTION OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY, AUTHORIZING THE PURCHASE OF VEHICLES IN THE POLICE DEPARTMENT

WHEREAS, the Director of Police has requested that the Township purchase two (2) 2020 Ford Fusion Sedans and six (6) 2020 Ford Police Interceptor SUV's for the Bloomfield Police Department,

WHEREAS the above described vehicles can be purchased under the Educational Services Commission of New Jersey #65MCESSCCPS - ESCNJ 17/18-44 and #65MCESSCCPS - ESCNJ 17/18-21 contracts respectively from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown, NJ 07936; and

WHEREAS Beyer Ford Fleet Leasing, has submitted a proposal to sell two 2020 Ford Fusion Sedans at a total cost of \$46,859.20; and


WHEREAS Beyer Ford Fleet Leasing, has submitted a proposal to sell six 2020 Ford Police Interceptor SUV's at a total cost of \$276,200.08; and

WHEREAS the Director of Finance has certified funds are available from the 2019 Current Operating Budget 9-01-25-745-051 Police Department - Purchase of Vehicles Account; and

NOW, THEREFORE, BE IT RESOLVED that the Mayor is authorized to and the Clerk to attest an agreement to purchase two 2020 Ford Fusion Sedans and six 2020 Ford Police Interceptor SUV's from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown 07936 at a total cost of \$323,059.28.


