WHEREAS, the Director of Public Works & Parks maintained the below list properties in the Township of Bloomfield; and

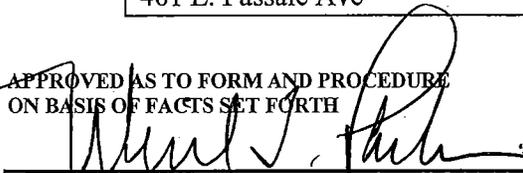
WHEREAS, these properties will now have a tax lien on them from the Township of Bloomfield.
