**DPW - LABORERS**

**WHEREAS**, the Township of Bloomfield Department of Public Works and Parks needs to two Laborers; and

**WHEREAS**, currently Lee Nasseh and Randall Mora Castro are working for the Township of Bloomfield Department of Public Works and Parks as permanent part-time employees; and

**WHEREAS**, the Director of the Department of Works and Parks is recommending that Lee Nasseh and Randall Mora Castro become DPW Laborers; and

**WHEREAS**, the Director of Finance has indicated that funding is available for these position.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby hires the above reference employees as full-time DPW Laborers effective January 1, 2017 starting at step 1, which is set forth in the Township salary ordinance for that position.

**BE IT FURTHER RESOLVED**, that this appointment is subject to the Bloomfield Township Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.
