WHEREAS, written application has been filed by Employee # 5793 for a leave of absence with pay; and

WHEREAS, Employee # 5793 has exhausted all his earned sick leave, vacation leave, personal leave, holiday leave, month days and all other leave earned with the Township of Bloomfield.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Employee # 5793 is hereby granted a leave of absence with pay from his position for a period of ninety (90) days effective December 10, 2016, provided, however, that the leave is conditioned upon the following:

1. During said leave of absence, Employee # 5793 will not accrue sick leave, vacation leave, personal leave, holiday time coming, holiday pay and uniform allowance, in accordance with the terms and conditions of the Collective Bargaining Agreement that controls the employee's employment.
2. During said leave of absence, employee shall continue to be covered for pension, health benefits, dental plan and prescription drug plan and life insurance in accordance with the terms and conditions of the agreement identified in paragraph 1 above.
3. During said leave of absence, if employee engages in any other gainful employment, his leave with the Township shall be automatically terminated.
4. Prior to his return to work the employee must submit a note from his Physician, who must certify to the employee's fitness to return to work.
