**2016 RESOLUTION AGREEMENTS**

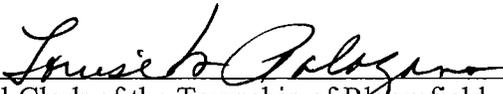
**MEMORANDUM OF UNDERSTANDING - 71 LOCUST AVE LLC**

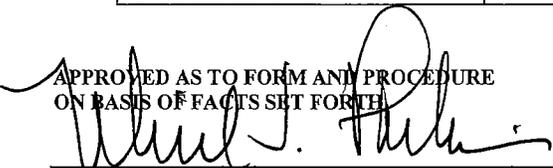
