**RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP
OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF
MELJUNN PASCUA v. TOWSHIP OF BLOOMFIELD CP# 2014-118822**

WHEREAS Meljunn Pascua has filed a Workers Compensation claim against the Township of Bloomfield for an injury occurring on December 17, 2013 which arose out of and in the course of his/her employment; and

WHEREAS a settlement has been proposed under Section 40 of the Workers Compensation Act; and

WHEREAS the settlement of this said matter is more fully set forth below and is in the best interests of the Township of Bloomfield

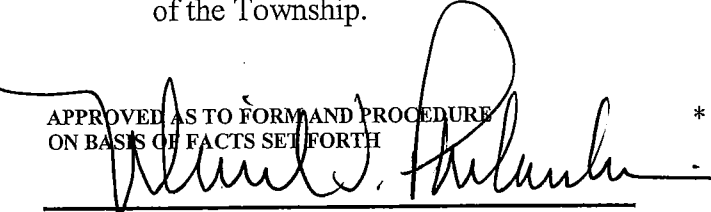
NOW, THEREFORE, BE IT RESOLVED, by the Township of Bloomfield, New Jersey, Steven J. Martino, Esq. is directed and empowered for and on behalf of the Township of Bloomfield to make, sign, execute and deliver an Order Approving Settlement with Meljunn Pascua in connection with his/her Workers Compensation claim; and

BE IT FURTHER RESOLVED, that the Order Approving Settlement will be drawn to include the following covenants, terms and conditions: 7 ½ % of the right foot for a gross award of 17.5 weeks @\$220.00 per week or \$3,795.00 plus the Township of Bloomfield's contributions towards attorney's fees and costs; and

BE IT FURTHER RESOLVED, that the sum total of the disbursements under the Order Approving Settlement shall be charged against the appropriate accounts in the Municipal budget of the Township.

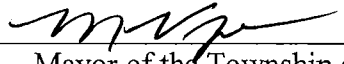
