RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF VERDUCCI v. TOWNSHIP OF BLOOMFIELD

WHEREAS Darlene Verducci has filed a personal injury claim against the Township of Bloomfield for an injury occurring on 4/30/2013 entitled Darlene Verducci v. Township of Bloomfield, Et Als., bearing Docket # ESX-L-6154-14; and

WHEREAS the claim was filed against the Township of Bloomfield for an injury suffered by Darlene Verducci; and

WHEREAS a proposed settlement was entered before a mediator, a copy of which is incorporated herein and as set forth at length; and

WHEREAS, the settlement of said matter as more fully set forth below is in the best interests of the Township of Bloomfield.

NOW, THEREFORE, BE IT RESOLVED, by the Township Of Bloomfield, New Jersey, that the settlement of Darlene Verducci vs. Township of Bloomfield, Et Als. is hereby authorized as follows:

- (a) \$145,000.00 payable to Darlene Verducci

BE IT FURTHER RESOLVED, that All Municipal Officials are hereby authorized to take whatever actions may be necessary to implement the terms of the Settlement; and

BE IT FURTHER RESOLVED, that the payment of the disbursement herein shall be charged against the appropriate accounts in the municipal budget of the Township.

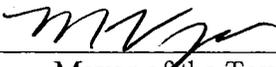
