WHEREAS, there are currently twenty-nine properties that need maintaining because of either they are either abandoned or are in foreclosure; and

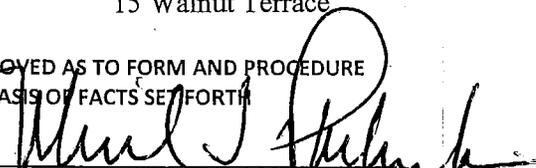
WHEREAS, the Director of Public Works & Parks maintained the below list properties in the Township of Bloomfield; and
