**RESOLUTION FOR THE EXECUTION OF AN APPLICATION TO  
CONSTRUCT/MODIFY/OPERATE PUBLIC WATER WORKS FACILITY FOR  
BLOCK 129, LOT 70, PARKSIDE AT BLOOMFIELD - SIMPLIFIED WATERMAIN  
EXTENSION**

**WHEREAS**, Bowman Consulting, on behalf of the developer Parkside at Bloomfield, hereafter referred to as "the Applicant" is making an application to the New Jersey Department of Environmental Protection (NJDEP), Division of Water Supply & Geoscience to modify the Bloomfield water system through construction of a watermain extension related to the construction of a thirty (30) unit, residential development at 58-76 Locust Avenue, also known as Block 129, Lot 70 on the Bloomfield Township Tax Maps; and

**WHEREAS**, this is a re-application of this permit due to the fact that the original permit has expired; and

**WHEREAS**, this modification requires that the Applicant re-file an application for a permit to construct/modify/operate public water works facility with the NJDEP; and

**WHEREAS**, this application requires a certification by a representative or representatives of the Township of Bloomfield under sections 6 and 7 of NJDEP Form BWSE-APPLICATION PA 01; and

**WHEREAS**, the plans and application materials were reviewed and approved by the Township Water Operator and were found to be acceptable.

**NOW, BE IT RESOLVED**, by the Mayor and Township Council that the Township Water Operator and the Mayor of the Township of Bloomfield are hereby authorized to execute form BWSE-APPLICATION PA 01 under Sections 6 and 7.
