2016 RESOLUTION AWARD OF CONTRACT

INTERCONNECTION METERING IMPROVEMENTS - AWARD OF CONTRACT

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on June 29, 2016 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for Interconnection Metering Improvements; and

WHEREAS, a total of two bids were received with the lowest bid price provided by Fred Devens Construction, 403 Stonetown Road, Ringwood, NJ 07456 at a contract price of \$218,226.00; and

WHEREAS, after review of the bid documents by the project consultant, Alaimo Group and the Township Engineer, it is recommended that the contract be awarded to Fred Devens Construction, 403 Stonetown Road, Ringwood, NJ 07456 at a contract price of \$218,226.00; and

WHEREAS, funding is available within the Township Capital Account number W-06-55-590-592.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above project with Fred Devens Construction, 403 Stonetown Road, Ringwood, NJ 07456 at a contract price of \$218,226.00.


