**2016 RESOLUTION BUDGETS**

**RESOLUTION REQUESTING APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION NJS 40A:4:87**

**BUDGET CHAPTER 159/8**

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

**WHEREAS**, said Director may also approve the insertion of any items of appropriation for equal amount; and


**WHEREAS**, after the 2016 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$30,000.00 from NJ DEP State Forest Services - Account # 6-01-08-386-000.

**NOW, THEREFORE, BE IT RESOLVED**, that the Township of Bloomfield hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the Budget of the year 2016 in the sum of \$30,000.00 as an anticipated revenue from NJ DEP - State Forest Service - Account # 6-01-08-386-000; and

**BE IT FURTHER RESOLVED**, that a like sum of \$30,000.00 be and the same is hereby appropriated under the Budget of the Township of Community Stewardship Incentive Program (CSIP) Grant Reforestation/Tree Planting - Account #6-01-40-386-000; and

**BE IT FURTHER RESOLVED**, that this resolution be filed with the Director of the Division of Local Government Services, Department of Community Affairs.


