2016 RESOLUTION GRANT AGREEMENTS

**STATE OF NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION
GREEN ACRES PROGRAM**

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres Program ("State"), provides loans and /or grants to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition and development of lands for outdoor recreation and conservation purposes; and

WHEREAS, Bloomfield Township desires to further the public interest by obtaining a grant of \$1,100,000.00 from the State to fund the following project:

Third River Park and Preserve**


– **WHEREAS**, Bloomfield Township anticipates additional Green Acres grants for this project subject to pending State legislative and administrative approvals.

NOW THEREFORE, the Bloomfield Township Council resolves that Matthew U. Watkins, Township Administrator, or the successor to the office of Matthew U. Watkins, Township Administrator, is hereby authorized to:

- (a) make application for such a loan and/or such a grant;
- (b) provide additional application information and furnish such documents as may be required;
- (c) act as the authorized correspondent of the above named applicant; and

WHEREAS, the State shall determine if the application is complete and in conformance with the scope and intent of the Green Acres program, and notify the applicant of the amount of the funding award; and

WHEREAS, the applicant is willing to use the State's funds in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the State for the above named project.


NOW, THEREFORE, BE IT RESOLVED BY THE BLOOMFIELD TOWNSHIP

COUNCIL THAT:


1. The Township Administrator of the above-named body is hereby authorized to execute an agreement and any amendment thereto with the State known as Third River Park and Preserve, and;
2. Bloomfield Township has its matching share of the project in the amount of \$2,409,732.14 in land value. This land value match is equal to 25% of the purchase price of the subject property which was acquired by the Township on February 2, 2015 for \$9,638,928.56. The Green Acres Urban Acquisition Program provides municipalities with 75% grant funds subject to a 25% match which can be achieved by cash or a land value; and
3. In the event the State's funds are less than the total project cost specified above, the applicant has the balance of funding necessary to complete the project; and
4. The applicant agrees to comply with all applicable federal, state and local laws, rules and regulations in its performance of the project; and
5. This resolution shall take effect immediately.
