2016 RESOLUTION GRANT AGREEMENTS

**STATE OF NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION
PASSAIC RIVER NATURAL RESOURCE RESTORATION PROGRAM GRANT
APPLICATION FOR LOWER PASSIAC RIVER AND TRIBUTARIES**

WHEREAS, the New Jersey Department of Environmental Protection, Office of Natural Resource Restoration ("State"), has established a new grant program available to governmental units for assistance in the restoration of land in the Lower Passaic River Basin and Passaic River Tributaries; and

WHEREAS, the DEP Commissioner and Spill Compensation Fund Administrator sued to recover costs and damages the state incurred as a result of historic discharges of hazardous substances into the Passaic River, Passaic Tributaries and the Newark Bay Complex; and

WHEREAS, restoration grants are awarded on a competitive basis to encourage local projects that provide public access and enjoyment and/or substantial ecological restoration; and

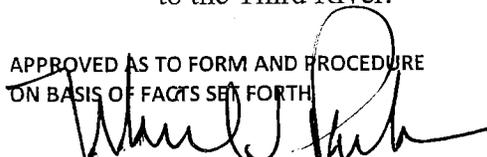
WHEREAS, litigants settled and transferred earlier this year \$67 million into a DEP trust fund intended to address lost human use services, impacts to land and water quality and recreational access; and

WHEREAS, Bloomfield Township desires to further the public interest by obtaining a grant not to exceed \$3,000,000.00 from the State to fund the following project:

Lions Gate Park Wetlands Creation

WHEREAS, Bloomfield Township anticipates utilizing funds prospectively awarded under this program to expand the wetlands creation project previously approved by the DEP Freshwater Wetlands Mitigation Council, and to provide enhanced environmental benefits and public access to the Third River.

NOW THEREFORE, the Bloomfield Township Council resolves that Matthew U. Watkins, Township Administrator, or the successor to the office of Matthew U. Watkins, Township Administrator, is hereby authorized to:

- (a) make application for such a grant;
- (b) provide additional application information and furnish such documents as may be required;
- (c) act as the authorized correspondent of the above named applicant; and

WHEREAS, the State shall determine if the application is complete and in conformance with the scope and intent of the Passaic River Natural Resource Restoration Program, and notify the applicant of the amount of the funding award; and

WHEREAS, Bloomfield Township is not required to provide match funding for this program; and

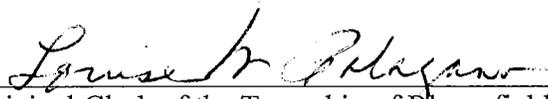
WHEREAS, Bloomfield Township is willing to use the State's funds in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the State for the above named project.

NOW, THEREFORE, BE IT RESOLVED BY THE BLOOMFIELD TOWNSHIP COUNCIL THAT:

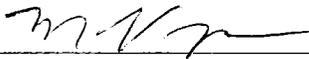
- 1. The Township Administrator of the above-named body is hereby authorized to execute an agreement and any amendment thereto with the State under the Passaic River Natural Resource Restoration Program, and;
- 3. The applicant agrees to comply with all applicable federal, state and local laws, rules and regulations in its performance of the project; and
- 5. This resolution shall take effect immediately.
