2016 RESOLUTION CHANGE ORDERS

WATERMAIN LOOPING PROGRAM - PHASE 1 - CHANGE ORDER NOS. 1 & 2 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the Watermain Looping Program - Phase 1 with John Garcia Construction Company, Inc., 183 Fries Lane, Clifton, New Jersey 07013 in the amount of \$400,090.56; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen site conditions; and

WHEREAS, the Township Engineer has reviewed the changes enumerated in Change Order Nos. 1 & 2 - Final and recommends the Change Orders be approved; and

WHEREAS, Change Order Nos. 1 & 2- Final represent a decrease in the cost of the contract in the amount of \$24,261.15 or a total reduction of 6.1% to the original contract price; and


WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and

WHEREAS, these Change Orders were found to be beneficial and necessary.
