WHEREAS, water charges on water account no. 9699000-1, 797 Broad St have been overpaid; and

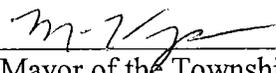

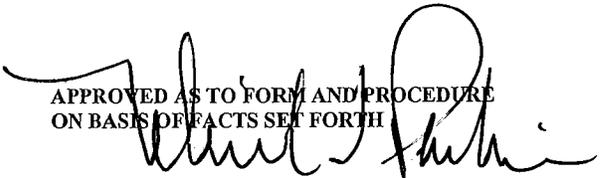
