2016 RESOLUTION CHAPTER 159

PROVIDING FOR THE INSERTION OF SPECIAL ITEMS OF REVENUE AND APPROPRIATION IN THE BUDGET CHAPTER 159/3


WHEREAS, the Governing Body (“Governing Body”) of the Township of Bloomfield finds and declares the N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services (“Director”), within the State of New Jersey Department of Community Affairs, may approve the insertion of any special item of revenue in the budget of any county or municipality; and

WHEREAS, the Governing Body further finds and declares that N.J.S.A. 40A:4-87 provides that the Director may also approve the insertion of any item an appropriation for an equal amount; and

WHEREAS, the Governing Body further finds and declares that it is the best interest of citizens of the Township to request approval of the insertion into the Township’s 2016 Municipal Budget of an item of revenue secured by the Township from the Borough of Heritage Village at Bloomfield, LLC - Account #6-01-08-369-000.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Township of Bloomfield does hereby request that the Director of the Division of Local Government Services, within the State of New Jersey Department of Community Affairs, approve the insertion into the Township’s 2016 Municipal Budget of an item of revenue in the sum of \$15,000.00, which item is now available as revenue from Heritage Village at Bloomfield, LLC - Account # 6-01-40-369-028; and


BE IT FURTHER RESOLVED, that a like sum of \$15,000.00 be and the same is hereby appropriated under the caption:

Heritage Village at Bloomfield, LLC


