2016 RESOLUTION CHAPTER 159

PROVIDING FOR THE INSERTION OF SPECIAL ITEMS OF REVENUE AND APPROPRIATION IN THE BUDGET CHAPTER 159/2

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of any items of appropriation for equal amount; and


WHEREAS, after the 2016 budget was adopted, the Township of Bloomfield became informed of the availability of revenue in the amount of \$362,728.00 from the Department of Homeland Security - Account # 6-01-08-366-000.

NOW, THEREFORE, BE IT RESOLVED, that the Township of Bloomfield hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the Budget of the year 2016 in the sum of \$362,728.00 as an anticipated revenue from the Department of Homeland Security - Account # 6-01-08-366-000.

BE IT FURTHER RESOLVED, that a like sum of \$362,728.00 be and the same is hereby appropriated under the Budget of the Township of Bloomfield FEMA Assist to Firefighters Grant - Account #6-01-40-366-028; and a match of \$36,272.00 to be appropriated; and

BE IT FURTHER RESOLVED, that this resolution be filed with the Director of the Division of Local Government Services, Department of Community Affairs.
