2016 RESOLUTION APPROVAL

AUTHORIZING DISPOSAL OF SURPLUS PROPERTY OF TOWNSHIP OF BLOOMFIELD

WHEREAS, the Township of Bloomfield is the owner of certain surplus property which it no longer needs for public use: and

WHEREAS, the Township of Bloomfield is desirous of selling said surplus property in an "as is" condition without express or implied warranties; and

WHEREAS, the Township will allow inspection of these vehicles at the location of 75 Federal Plaza on the following dates and times: Saturday, June 4th and Wednesday, June 8th between the hours of 8 am and 11 am on either date. No appointment necessary.

- (1) The sale of the surplus property shall be conducted through GovDeals pursuant to State Contract A-83453/T2581 in accordance with the terms and conditions of the State Contract. 
