2016 RESOLUTION LEASE/PURCHASE AGREEMENTS

2016 PURCHASE OF VEHICLES, POLICE DEPARTMENT

WHEREAS, the Director of Police has requested that the Township purchase six Ford Police Interceptors for the Bloomfield Police Department; and

WHEREAS, the above described vehicles can be purchased under the Morris County CO-OP Contract #15-A item #5 from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown, NJ 07936; and

WHEREAS, Beyer Ford Fleet Leasing, has submitted a proposal to sell two 2016 Ford Police Interceptor Utility to the Bloomfield Police Department at a cost of \$26,597.25 and four 2016 Police Interceptor Utility at a cost of \$25,617.75; and

WHEREAS, the Director of Finance has certified funds are available in the Operating budget; and


WHEREAS, the Director of Finance will make 3 (three) annual payments of \$80,613.66 for the next three years.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor is authorized to sign and the Clerk to attest an agreement to purchase six 2016 Ford Police Interceptor Vehicles from Beyer Ford Fleet & Leasing, 170 Ridgedale Avenue, Morristown, NJ 07936 at a total cost of \$231,683.72.


