2016 RESOLUTION CHANGE ORDERS

CHANGE ORDER NO. 1 - FINAL - ESSEX AVENUE - SECTIONS 1 & 2

WHEREAS, the Township of Bloomfield entered into a contract for Essex Avenue Roadway Improvements - Sections 1 and 2 with Stanziale Construction, LLC, P.O. Box 2597, Bloomfield, NJ 07003 (hereinafter "the Contractor"); and

WHEREAS, this project was performed under a shared service agreement with the Borough of Glen Ridge because the roadway is shared between the two municipalities; and

WHEREAS, the total contract price for this project was \$1,194,001.01 with Bloomfield's portion being \$659,423.00 and Glen Ridge's portion being \$534,576.71; and

WHEREAS, during the course of construction, additional work was required due to unforeseen subsurface conditions including encountering rock outcroppings which required additional excavation as well as a series of conflicting utilities, particularly along the connection of new storm sewer facilities with those of Essex County at various intersections on Broad Street; and

WHEREAS, these changes resulted in an increase in the Township of Bloomfield's portion of the work in the amount of \$128,601.43 or 19.5%; and

WHEREAS, it is the opinion of the Bloomfield Township Engineer that these changes were necessary; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer is satisfied that the Change Order should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Chief Financial Officer certifies that funding is available within
