2016 RESOLUTION APPOINTMENT

APPOINTMENT, DEPUTY MUNICIPAL COURT ADMINISTRATOR

WHEREAS, the Township of Bloomfield needs a Deputy Municipal Court Administrator in the Municipal Court to perform all of the duties and responsibilities set forth in the Charter of the Township of Bloomfield, its by-laws, ordinances and laws of the State of New Jersey; and

WHEREAS, Judesca Correa is currently a senior office assistant in the Piscataway Municipal Court and has indicated a desire to be appointed to the Deputy Municipal Court Administrator; and

WHEREAS, Judesca Correa has indicated that if appointed to the position of Deputy Court Administrator she will comply with all of the requirements that are necessary to maintain the position; and

WHEREAS, the Chief Judge of the Bloomfield Municipal Court recommends appointing Judesca Correa to the position of Deputy Court Administrator; and

WHEREAS, the Director of Finance has certified that funds are available to cover the cost of this position.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Judesca Correa is hereby appointed Deputy Municipal Court Administrator upon final approval from the Assignment Judge Sallyanne Floria; and

BE IT FURTHER RESOLVED, that Judesca Correa will be starting at step 1 in the salary ordinance of the Township of Bloomfield for that position.
