
2016 RESOLUTION ABC SUSPENSIONS

2016 MOON PALACE, INC.

WHEREAS, on or about January 8, 2016, Moon Palace, Inc., was served with the attached Notice of Charges seeking penalties which in there totality were seeking revocation of license No.:0702-33-020-005; and

WHEREAS, in lieu of facing a hearing, Moon Palace, Inc., has requested, and the Township of Bloomfield agrees, that the following penalties and conditions be imposed: (1) a thirty day suspension (which voluntarily began on January 20, 2016); (2) a condition on the license that it shall not be used for the sale of alcoholic beverages for consumption on the premises; (2) license shall be exclusively used, to the extent permitted by law, for the sale of prepackaged goods only (if the law does not allow the sale of prepackaged goods, the parties recognize that license is effectively revoked by this agreement); (3) no alcoholic beverages allowed to be consumed on the premises where the license is being held under any circumstances (no bring your own); (4) current premises where license is held cannot reopen for the sale of prepackaged goods (for consumption elsewhere) unless all laws, rules, regulations, codes and zoning requirements are met; (5) the Township makes no representations as to the ability to perform any work of alter the premises in any manner (any necessary permits or changes to the premises must be applied for in the regular course of business); (6) all prior conditions regarding the necessity of police officers during operating hours and the like, are hereby lifted, because no consumption of alcohol shall take place on the premises; and (7) any future holder of the license can make application to lift the condition prohibiting consumption, which shall be granted or denied in the Council's sole discretion, based upon desired location of use and other factors.
