2016 RESOLUTION GRANT AGREEMENTS

AUTHORIZING THE TOWNSHIP OF BLOOMFIELD OFFICE OF EMERGENCY MANAGEMENT TO ACCEPT FUNDS FROM A SUBGRANT AWARD OF THE FEDERAL FISCAL YEAR 2015 OF EMERGENCY MANAGEMENT AGENCY ASSISTANCE PROGRAM FUNDING AND FOR THE CHIEF FINANCIAL OFFICER OF THE TOWNSHIP OF BLOOMFIELD TO AMEND THE BUDGET AND CERTIFY THE AVAILABILITY OF FUNDS

WHEREAS, the Township of Bloomfield, Office of Emergency Management has been awarded Emergency Management Agency Assistance Subgrant Program ("EMAA") from the New Jersey State Police Office of Emergency Management Agency available for successful applicants funded through the FY2015 Emergency Management Performance Grant for the dates of July 1, 2015 through June 30, 2016; and

WHEREAS, the Subgrant consisting of a total amount of \$14,000 (including \$7,000 Federal Award and \$7,000 Local Matching Funds) which the Bloomfield Office of Emergency Management will satisfy with the Office of Emergency Management existing salaries and wages.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that the Township Administrator, the Township Chief Financial Officer and the Township's Emergency Management Coordinator are hereby authorized to sign the required Grant Applications/Subgrant Award Documents with the New Jersey State Police, Office of Emergency Management and to accept such funds; and

BE, IT FURTHER RESOLVED, that copies of this resolution shall be forward to the New Jersey State Police Office of Emergency Management, the Essex County Office of Emergency Management, the Director of the Division of Local Government Services, the Township of Bloomfield's Office of Emergency Management, the Township Administrator and the Township's Chief Financial Officer.
