**2016 RESOLUTION WATER OVERPAYMENTS**

**CANCEL PRIOR YEAR WATER UTILITY OVERPAYMENTS**

WHEREAS, certain prior years' tax overpayments remain un-refunded on the Township of Bloomfield water utility records; and


WHEREAS, a review of these accounts has revealed that the properties no longer have water service from the township, prior owners of record have moved, or whom to refund is undeterminable; and said water utility overpayments are now un-refundable; and

WHEREAS, the total water utility overpayments amount to \$566.85 as analyzed:
