2016 RESOLUTION CHANGE ORDERS

CONGER STREET & GLENWOOD AVENUE INTERSECTION IMPROVEMENTS - CHANGE ORDER NO. 1 - FINAL

WHEREAS, the Township of Bloomfield entered into a contract for the Conger Street & Glenwood Avenue Intersection Improvements with Foggia Trinity Electric, LLC, Inc., 1759 E. 2nd Street, Scotch Plains, New Jersey 07076 for a total contract cost of \$347,138.50; and

WHEREAS, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen site conditions; and

WHEREAS, the Township Engineer has reviewed the changes enumerated in Change Order No. 1 - Final and recommends the Change Order be approved; and

WHEREAS, Change order No. 1- Final represents a decrease in the cost of the contract in the amount of \$1,815.40 and


WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and

WHEREAS, the Director of Finance has certified that the funds are available within Township Account #5-02-40-213-000 and is reimbursable through a grant from the New Jersey Department of Transportation Trust Fund.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final is hereby approved and the Financial Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work.
