RESOLUTION: AUTHORIZING THE DISCHARGE OF RESIDENTIAL REHAB PROGRAM MORTGAGE LIEN FOR 27 ROWE STREET IN THE TOWNSHIP OF BLOOMFIELD

WHEREAS, the CDBG program provided a forgivable loan to residents who request help to improve their homes within the Township of Bloomfield.


WHEREAS, in 2007 the homeowners of 27 Rowe Street signed an agreement that a lien would be filed against the property place as part of the conditions of the loan; and
