**WHEREAS**, the Director of Finance has indicated that funding is available for this position; and


**WHEREAS**, this position is a non-exempt position.

**BE IT FURTHER RESOLVED**, that this appointment is subject to the Bloomfield Township Code Chapter 88 Residency Requirements, which requires the employee to be a bona fide resident of the Township of Bloomfield and to maintain such residency and failure of any such employee to maintain residency in the Township of Bloomfield shall cause for removal and discharged from employment.




