**RESOLUTION: AUTHORIZING THE EXECUTION OF A FIRST AMENDMENT TO THE PARKING GARAGE CONSTRUCTION AGREEMENT FOR THE ROYAL THEATER LOT REDEVELOPMENT PROJECT**

**WHEREAS**, the Mayor and Council of the Township of Bloomfield adopted Resolution No. 7190 designating Royal Urban Renewal, LLC, an affiliate of Metro Real Estate Development Corp. (“Redeveloper”) as redeveloper of a portion of the Redevelopment Area known as Block 227, Lots 1, 24, 26, 30, 31, 32, and 35 (“Project Area”); and

**WHEREAS**, the Mayor and Council adopted Resolution No. 7190 authorizing the execution of a Redevelopment Agreement (the “Agreement”) between the Township and Redeveloper; and

**WHEREAS**, the Agreement details the construction of a Parking Garage, comprising a Rental Residential Component and a Townhouse Component, and the entry of agreements between the Township and Redeveloper in connection with the construction of the Parking Garage; and

**WHEREAS**, the Mayor and Council adopted Resolution R19-202 authorizing the Township to execute any and all necessary documents regarding a Parking Garage Construction Agreement; and

**WHEREAS**, in preparation of the Parking Construction Agreement, the Parties negotiated the costs and pricing for the construction of the Royal Garage, and specifically determined that the definition of Stipulated Sum as set forth in the Parking Construction Agreement should be Six Million Seven Hundred Sixty Thousand Dollars (\$6,760,000.00); and

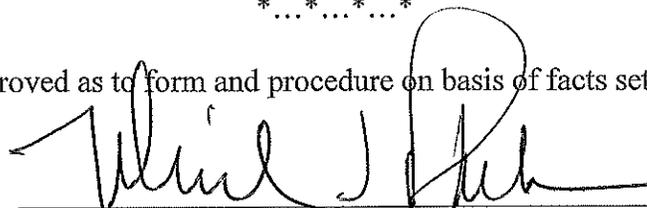
**WHEREAS**, notwithstanding the agreement of the Parties, the definition of Stipulated Sum set forth in the Parking Construction Agreement was incorrect, and not in accordance with the agreement of the Parties; and

**WHEREAS**, the Parties have determined to enter into this First Amendment to modify the definition of Stipulated Sum in the Parking Construction Agreement to be consistent with the agreement of the Parties and to make additional changes consistent with the modification of the definition of Stipulated Sum.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorizes the Township Administrator or his designee to execute any and all necessary documents regarding A First Amendment to the Parking Garage Construction Agreement for the Royal Theater Lot Redevelopment Project.

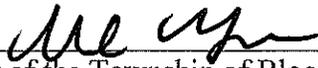
