2020 RESOLUTION APPROVAL

RESOLUTION: TEMPORARY WAIVER OF INTEREST ON DELINQUENT TAXES OR ASSESSMENTS

HEREAS, the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, adopted Resolution R-20-03 establishing the rate of interest to be charged for the non-payment of taxes or assessments on or after the date when they become delinquent; and

WHEREAS, many residents of the Township of Bloomfield, like those throughout the state and nation, have been adversely affected by the COVID-19 pandemic and State of Emergency; and

WHEREAS, Governor Phil Murphy's latest Executive Order has ordered the closure of all non-essential retail businesses in the state, while many other businesses have experienced closures and layoffs as a result of the stay at home orders, with the potential of leaving many residents out of work.

WHEREAS, the grace period of ten (10) calendar days shall be extended to thirty (30) calendar days with delinquent interest on property taxes due on May 1, 2020 charged as follows:


1. No interest shall be charged if payment of the May 1, 2020 installment is made within the thirtieth calendar day following May 1, 2020; and
2. Upon expiration of the thirty (30) calendar day period as aforesaid; the rate of interest shall be eight percent (8%) per annum on the first \$1,500.00 of the delinquency and eighteen percent (18%) per annum interest to be charged for delinquency of sums in excess of \$1,500.00; and

3. Interest to be calculated from May 1, 2020 until the date of actual payment.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that the grace period for property taxes due on May 1, 2020 shall be extended from ten (10) days to thirty (30) days.


