2020 RESOLUTION APPROVAL

RESOLUTION OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY, CALLING ON ALL RESIDENTS TO PROPERLY DISPOSE OF THEIR PERSONAL PROTECTIVE EQUIPMENT

WHEREAS, in light of the dangers posed by COVID-19 (“coronavirus”), on March 9, 2020, Governor Phil Murphy declared both a Public Health Emergency and State of Emergency; and

WHEREAS, to further protect the health, safety and welfare of all residents by reducing the rate of community spread of COVID-19, the state established mitigation strategies for combatting COVID-19; and

WHEREAS, many New Jersey residents fearful of spreading or contracting the coronavirus are leaving their homes wearing protective face masks and gloves, and using disposable sanitizing wipes; and

WHEREAS, Township of Bloomfield officials are receiving numerous complaints about disposable masks, wipes and gloves being illegally discarded on sidewalks and streets; and

WHEREAS, Section 497-44 of the Township of Bloomfield Code, entitled “Littering”, forbids all persons from throwing rubbish, refuse or any other matter upon the sidewalks, gutters or streets within the Township, and provides penalties up to \$2,000 for violations; and

WHEREAS, in addition to littering being illegal and unacceptable, dumping protective gloves, wipes and masks on the streets, sidewalks and parking lots of Bloomfield creates potentially dangerous conditions for those responsible for cleaning it up and puts our neighbors at risk; and

WHEREAS, the Mayor and Council of the Township of Bloomfield call on all residents to respect our environment and neighbors by properly disposing of their protective gloves, wipes and masks in trash receptacles; and

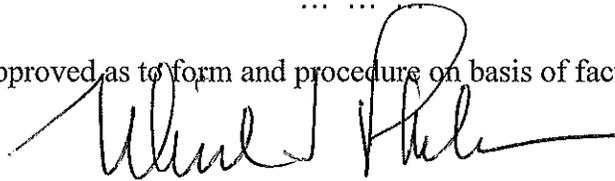
WHEREAS, the Mayor and Council of the Township of Bloomfield encourage all owners and managers of open, essential businesses in Bloomfield to provide for an adequate number of available trash receptacles in their parking lots and on their properties to allow for patrons to properly dispose of their gloves, wipes and masks used while shopping; and

WHEREAS, the Mayor and Council further call for increased enforcement of littering and illegal dumping laws to combat the improper disposal of protective gloves, wipes and masks throughout the Township.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, that all residents are strongly encouraged to properly dispose of their used personal protective equipment, such as face masks, wipes and gloves, in appropriate trash receptacles, and are reminded of the penalties for littering in the Township.
