**2020 RESOLUTION - AWARD OF PROFESSIONAL SERVICES - LEAD SERVICE  
LINE REPLACEMENT PHASE 2 - EXPLORATORY WORK**

**WHEREAS**, the Township Of Bloomfield Engineering Department requires consulting services for design and construction administration services for exploratory work to identify the locations of lead service lines within the water distribution system of the Township of Bloomfield; and

**WHEREAS**, this work has been determined by the Township Engineer and Licensed Water Operator to be necessary and beneficial to identify and locate lead service lines within the Bloomfield Water System so that they can be removed and replaced with copper piping; and

**WHEREAS**, this work is required to be performed as part of the Township's Asset Management Plan and Corrective Action Plan on file and approved by the NJDEP to properly remove and mitigate for the presence of lead within the Bloomfield Water Distribution system; and

**WHEREAS**, T & M Associates, 1455 Broad Street, Suite 250, Bloomfield, NJ 07003 (hereinafter "the Consultant") was previously awarded a contract by the Township of Bloomfield to provide General Engineering Services for this type of work in 2020; and

**WHEREAS**, the consultant has provided a proposal to provide consulting services for design and construction administration to explore and identify for the presence of lead service connections at over 500 locations in the amount of \$42,650.00; and

**WHEREAS**, the Bloomfield Township Engineer has determined that these services are necessary and beneficial to maintain proper drinking water quality; and


**WHEREAS**, the Bloomfield Township Engineer further recommends that these services be awarded to the consultant at a cost not to exceed \$42,650.00 under their current 2020 General Engineering Services Contract; and

**WHEREAS**, the Director of Finance has indicated that funding is available in Township Account Number W-06-55-592-500.

**NOW THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accept the recommendation of the Bloomfield Township Engineer and the Consultant is hereby authorized to perform the above work at a cost not to exceed \$42,650.00.




