**2020 RESOLUTION AGREEMENTS**

**RESOLUTION: SUBRECIPIENT AGREEMENT FOR USE OF HOMELESS TRUST FUNDS BETWEEN ESSEX COUNTY, NEW JERSEY AND THE TOWNSHIP OF BLOOMFIELD**

**WHEREAS**, under the County Homelessness Trust Fund Act, N.J.S.A. 52:27D-287a, et seq. (the "Act"), the New Jersey Legislature finds and declares that "[d]espite laudable efforts by all levels of government, private individuals, nonprofit organizations, townships and charitable foundations to end homelessness, the number of homeless persons in New Jersey is unacceptably high. The State's homeless population, furthermore, includes a large number of families with children, youth, and veterans, the elderly, and employed persons." N.J.S.A. 52:27D-287b(b). Further, "The fiscal and social costs of homelessness are high for both the public and private sectors," and as a result the New Jersey Legislature has declared that "ending homelessness should be a joint goal for State and local government." N.J.S.A. 52:27D-287b(c); and

**WHEREAS**, the County OF Essex, in consultation with the County Department of Community Affairs, has established a County Homelessness Housing Trust Fund ("HTF"), a County homeless housing grant program under the Act, and has developed strategies to address the needs of the homeless within Essex County, N.J.S.A. 52:27D-287d; and

**WHEREAS**, The County's 2020 HTF has been approved by the Board of Chosen Freeholders in Resolution No. 2020-00358 on April 29, 2020, in a capped amount of \$400,000, with a capped amount of \$200,000 to each Subrecipient for the implementation of HTF-eligible services for the homeless who are seniors; and

**WHEREAS**, the Township of Bloomfield submitted a proposal responding to the County's Request for Proposals (RFP) # 20-009, for services to the County's homeless who are


seniors. A subcommittee of the County's Homeless Trust Fund Task Force of the County's Department of Citizen Services, Division of Community Action reviewed all proposal for experience, resources and capacity to provide a full panoply of services regarding permanent housing and wraparound services to homeless seniors; and

**WHEREAS**, based upon Bloomfield's responses regarding experience and resources, Bloomfield was one of the successful applicants as it has the experience and ability to provide the full-range of required services to homeless seniors including, but not limited to permanent housing and other supportive services.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby authorizes the Mayor or his designee to execute the attached Subrecipient Agreement for use of Homeless Trust Funds between Essex County and the Township of Bloomfield.
