RESOLUTION: APPROVING THE HIRE OF FOUR PER DIEM/SEASONAL WORKERS FOR RECREATION PROGRAMMING

WHEREAS, the Township Administrator is responsible for the day to day business operations of the Township of Bloomfield; and
