**2020 RESOLUTION AWARD OF CONTRACT**

---

**RESOLUTION: EMERGENCY REPAIR AUTHORIZATION**

**WHEREAS**, on August 18, 2020 the Bloomfield Department of Recreation and Cultural Affairs was notified of a significant lighting strike at their facilities at Memorial Park which resulted in complete loss of electrical service. The Bloomfield Department of Public Works Electrical Division assessed the damages and determined that the main electrical panel that feeds the facility was completely destroyed by the lighting strike resulting in a potential hazard to the general public; and

**WHEREAS**, it was the recommendation of the Township Engineer that this work constituted an emergency situation due to lack of electricity, lighting and security at these facilities as well as the potential hazard of an existing, damaged, exposed electrical service.; and

**WHEREAS**, the determination was made by the Public Works Department and confirmed by the Bloomfield Engineering Department that an outside electrical contractor was required to repair the damage; and

**WHEREAS**, Giordano Electrical Corporation, 2360 Lakewood Road, Suite 3; #450, Toms River, NJ 08755 (the Vendor) was able to answer the emergency call within the short time frame and subsequently dispatched a crew to evaluate the damage and make repairs; and

**WHEREAS**, in addition to the lighting damage the Vendor also determined that

the current electrical configuration was out of code and needed upgrading as well as replacement of the electrical panel to safely restore the electrical service to the facility; and

**WHEREAS**, the Vendor provided a proposal to provide the required services at a cost of \$31,500.00; and

**WHEREAS**, the proposal was reviewed by the Township Engineer and found to be complete and competitive and approved the vendor to proceed with the work; and

**WHEREAS**, the Chief Financial Officer has certified the availability of funds to pay the contract in capital account C-04-55-732-000; and

**WHEREAS**, the emergency work commenced and was completed by September 14, 2020; and

**WHEREAS**, pursuant to the provisions of N.J.S.A. 40A: 11-6 and the Township Code, the approval of the Council of the Township of Bloomfield is required in order to make payment to the vendors, for the contract price of the Services;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWNSHIP OF BLOOMFIELD:**

1. That payment to the vendor be made part hereof, of the contract prices for the Emergency Repairs of the electrical service at Memorial Park.
2. That said payment represents the total cost of the work.
3. That the Clerk of the Township of Bloomfield forward two (2) certified copies of this resolution to the Chief Financial Officer and one copy to the Township Engineer.

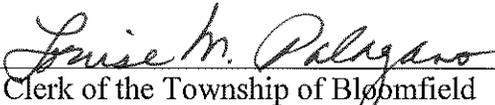

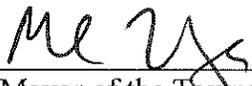
