**RESOLUTION OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY, AUTHORIZING THE PURCHASE OF REPLACEMENT EQUIPMENT (Toro Groundsmaster 7200 and Mulching Kit) FOR THE DEPARTMENT PUBLIC WORKS**

**WHEREAS**, the Director of Department of Public Works has requested that the Township replaces the damage Township cutter; and

**WHEREAS**, Storr Tractor Company, has submitted a proposal to sell a Toro Groundsmaster 7200 and Mulching Kit at a total cost of \$21,041.42; and

**WHEREAS**, the Director of Finance has certified funds are available in account # C-04-55-865-969; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor is authorized to execute and the Clerk to attest an agreement to purchase Toro Groundsmaster 7200 and Mulching Kit from Storr Tractor Company, 3191 Route 22, Branchburg, NJ 08876 at a total cost of \$21,041.42.


