**2020 RESOLUTION AWARD OF CONTRACT**

**RESOLUTION: AUTHORIZING THE 2020 AWARD OF A NON-FAIR AND OPEN CONTRACT FOR A PROFESSIONAL ALLIED NETWORK TECHNOLOGIES**

**WHEREAS**, the Township of Bloomfield Parking Utility needs IT Management services for their network; and

**WHEREAS**, the Township desires to make this appointment under the provisions *N.J.S.A. 19:44A-20.5*, as a non-fair and open contract; and

**WHEREAS**, the Township Administrator has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, Allied Network Technologies LLC has completed and submitted the attached Business Entity Disclosure Certification which certifies that it has not made any reportable contributions to a political or candidate committee in the Township of Bloomfield in the previous year, and that the contract will prohibit Allied Network Technologies LLC from making any reportable contributions through the duration of this contract; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in account # 0-07-20-512-028 in the amount not to exceed \$50,000.00.

**NOW, THEREFORE, BE RESOLVED**, that the Mayor and Council of the Township of Bloomfield authorizes the Township Administrator to enter into a contract with Allied Network Technologies LLC as described herein; and

**BE IT FURTHER RESOLVED**, that no minimum payment is implied or guaranteed; and

**BE IT FURTHER RESOLVED**, that the Business Disclosure Entity Certification, the Township Administrator's Determination of Value, the proposal of Allied Network Technologies LLC and the contract itself be placed on file with this resolution; and


**BE IT FURTHER RESOLVED**, that the above documents shall be available for public inspection at the office of the Township Clerk during regular business hours; and

**BE IT FURTHER RESOLVED**, that in accordance with Standardized Submission Requirements the Township reserves the right to cancel this contract upon thirty (30) days notice and the Professional shall only be paid for the work completed or on a pro-rated amount if the contracts calls for a monthly retainer; and

**BE IT FURTHER RESOLVED**, that a notice of this action shall be printed once in the official newspaper of the Township of Bloomfield.
