**2020 RESOLUTION AGREEMENTS**

**RESOLUTION: AUTHORIZING THE TOWNSHIP OF BLOOMFIELD RECREATION DEPARTMENT TO APPLY FOR A GRANT REGARDING THE SPECIAL NEEDS PROGRAM WITH NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS**

**WHEREAS**, the Township of Bloomfield desires to apply for and obtain a grant from the New Jersey Department of Community Affairs for \$20,000 to carry out a project to provide inclusive recreational opportunities for individuals with developmental disabilities as a part of Bloomfield's recreational programming to benefit developmentally disabled individuals ages four through adult; and

**WHEREAS**, the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey does hereby authorize the Mayor and/or the Township Administrator or his designee to apply for such grant; and

**WHEREAS**, the Township recognizes and accepts that the Department may offer a lesser or greater amount, and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such agreement; and also upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Township of Bloomfield and the New Jersey Department of Community Affairs; and

**WHEREAS**, Mayor and Council of the Township of Bloomfield authorizes the expenditure of the required 20% match for this grant.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that the Mayor and or Township
