RESOLUTION: APPROVING THE TOWNSHIP'S GROUP DENTAL PLAN WITH DELTA DENTAL PLAN OF NEW JERSEY, INC.

WHEREAS, RD Parisi Assoc., is currently the Township's Dental benefits broker; and

WHEREAS, RD Parisi Assoc. has received quotes to provide the Township Dental benefits from four providers; and

WHEREAS, Delta Dental has proposed a 36 month dental program for both active and retired employees, with no increase to current rates for the duration of the contract term; and

WHEREAS, the Director of Finance has review the proposal submitted and recommends that the Township enter into an agreement with Delta Dental for 3 years at the proposed rates; and

WHEREAS, the Director of Finance has certified that funding is available.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor is hereby authorized to sign and the Clerk to attest and affix the seal of the Township of Bloomfield to an agreement between the Township of Bloomfield, in the County of Essex, New Jersey, and Delta Dental Plan of New Jersey, Inc., for renewal of the Township's Group Dental Plan #3283, effective January 1, 2021 through December 31, 2023.
