2020 RESOLUTION AWARD OF CONTRACT

RESOLUTION: AWARD OF PROFESSIONAL SERVICES - LEAD SERVICE LINE REPLACEMENT - CONTRACT 3

WHEREAS, the Township Of Bloomfield Engineering Department requires consulting services for design and construction administration services for preparation of bid documents and construction administration for the replacement of approximately 200 known lead service lines; and

WHEREAS, this work has been determined by the Township Engineer and Licensed Water Operator to be necessary in order to comply with The New Jersey Department of Environmental Protection Division of Water Supply requirement to replace all known lead service lines in an expedient method; and

WHEREAS, this work is required to be performed as part of the Township's Asset Management Plan and Corrective Action Plan on file and approved by the NJDEP to properly remove and mitigate for the presence of lead within the Bloomfield water distribution system; and

WHEREAS, T & M Associates, 1455 Broad Street, Suite 250, Bloomfield, NJ 07003 (hereinafter "the Consultant") was previously awarded a contract by the Township of Bloomfield to provide General Engineering Services for this type of work in 2020; and

WHEREAS, the consultant has provided a proposal to provide consulting services for design and construction administration to prepare bid documents; construction administration and assistance with obtaining I-Bank Funding to remove approximately 200 lead service lines locations in the amount of \$175,700.00; and

WHEREAS, the Bloomfield Township Engineer has determined that these services are necessary and beneficial to maintain proper drinking water quality; and


WHEREAS, the Bloomfield Township Engineer further recommends that these services be awarded to the consultant at a cost not to exceed \$175,700.00 under their current 2020 General Engineering Services Contract; and

WHEREAS, the Director of Finance has indicated that funding is available in Township Account Number W-06-55-592-500.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accept the recommendation of the Bloomfield Township Engineer is hereby authorized to perform the above work at a cost not to exceed \$175,700.00.
