WHEREAS, the Director of Public Safety recommends that the following Class Two Special Law Enforcement Officers be re-appointed to their positions; and

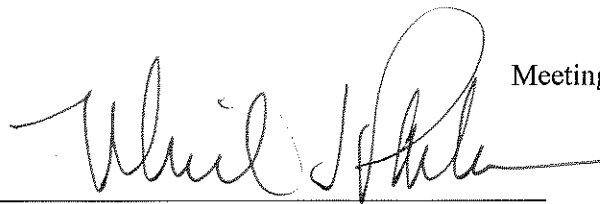

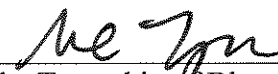
