2021 RESOLUTION AUTHORIZATIONS

RESOLUTION AUTHORIZING THE TOWNSHIP ENGINEER AND LICENSED WATER OPERATOR AS AUTHORIZED REPRESENTATIVE FOR THE NEW JERSEY INFRASTRUCTURE BANK FOR THE TOWNSHIP'S LEAD SERVICES REPLACEMENT (MULTI-PHASE) PROJECT, TOWNSHIP OF BLOOMFIELD, ESSEX COUNTY, NJ

NJIB LOAN NO. 0702001-005

WHEREAS, the Township of Bloomfield intends to file a loan application with the New Jersey Department of Environmental Protection and the New Jersey Infrastructure Bank for the Township's Lead Services Replacement (Multi-Phase) Project; and

WHEREAS, the Township proposes to replace existing lead service lines as a result of an action level exceedance. The Township will conduct investigations to identify existing lead service lines throughout the Township. Construction contracts will be prepared in phases to replace identified lead service lines from the existing water main up to curb and include the replacement of the curb box. Additionally, if necessary, lead service lines may also be replaced from the new curb box up to the water meter located inside the property lot if the existing pipe cannot be verified to be constructed of copper or galvanized piping. Other improvements to be included in each phase contract includes the site restoration of the trench as necessary.

NOW, THEREFORE BE IT RESOLVED, that Paul D. Lasek, Township Engineer and licensed water operator, be authorized to act as the Authorized Representative to represent the Township in all matters relating to the projects undertaken pursuant to the above referenced New Jersey Environmental Infrastructure Loan to be executed with the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust. 




