2021 RESOLUTION APPROVAL

RESOLUTION AUTHORIZING THE TAX COLLECTOR TO CREDIT INTEREST CHARGED ON 2ND QUARTER 2020 TAXES FOR BLOCK 829, LOT 24

WHEREAS, the owners of Block 829, Lot 24, also known as 41 Fritz Street, (“Owners”) state their 2nd Quarter 2020 tax payment was made timely to the Township; and

WHEREAS, the Owners further state they did not realize their May 2020 tax payment was not received by the Township until August 2020, when they came into the Township Tax Office to make their 2020 3rd quarter tax payment; and

WHEREAS, since the tax office did not receive the 2nd Quarter payment within the 10-day grace period, which would have been May 10, 2020, interest on the late payment in the amount of \$93.75 was charged to the account; and

WHEREAS, the Owners requested waiver of the interest charged since they stated their payment was timely when delivered to the Police Department while the municipal building was closed to the public due to the COVID-19 pandemic; and


WHEREAS, the Township Administrator has indicated the interest may be waived; and

WHEREAS, since the taxes are paid to date, the Tax Collector can issue a credit towards the taxes due for the 2021 1st Quarter on this account.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that the Tax Collector is hereby authorized to execute a credit to the 2021 1st Quarter taxes in the amount of \$93.75, which represents interest accrued on the 2020 2nd Quarter taxes.




