2021 RESOLUTION APPROVAL

RESOLUTION: ADOPTION OF THE 2021 BLOOMFIELD CENTER ALLIANCE, INC. BUDGET

WHEREAS, the Bloomfield Center Alliance, Inc. has submitted its detailed 2021 Budget for approval by the Mayor and Council of the Township of Bloomfield; and

WHEREAS, the Mayor and Council of the Township of Bloomfield have reviewed the 2021 Bloomfield Center Alliance, Inc. Budget; and

WHEREAS, pursuant to N.J.S.A. 40:56-84, the budget shall be introduced, approved, amended and adopted by resolution passed by not less than a majority of the full membership of the governing body; and

WHEREAS, the budget was introduced in writing at the January 25, 2021 meeting of the governing body, and the 2021 Bloomfield Center Alliance, Inc. budget was approved

WHEREAS, the budget shall not be adopted until a public hearing has been held thereon, which hearing shall be held not less than 28 days after the approval of the budget; and




